Dear Competitor,

Enclosed are the supplementary Regulations and Entry Form for the second (2) CSCA round this year, jointly hosted by MG Car Club Ltd of Sydney, & MG Car Club Newcastle to be run on the **Eastern Creek International Raceway**, on **SATURDAY 17<sup>th</sup> April, 2010**. **Track Hire & CAMS Fees have increased this year, so the Entry Fees have also increased somewhat.**

The event is open to financial members of CSCA clubs as listed in the Supplementary Regulations.

The growing popularity of CSCA Supersprints, suggests that demand may exceed the fixed supply of 100 - 110 places. We recommend that you send your entry form and fee by return mail in order to secure your place.

Please note that the Entry Form can be filled in electronically to avoid any issues with illegible hand writing, & be sure answer all fields and include your E-mail address. That will allow us to send results electronically. **Note that the entry form cannot be lodged electronically, and we will not accept modified Entry Forms – use the one provided below!**

Also note that ALL Vehicles Must comply to CAMS General Requirements of Automobiles; most competitors should now be aware of the requirements; if in doubt about what class you will be competing in PLEASE contact your club competition secretary FIRST for advice.

This Event will be Electronically timed using Dorian Timing Units. These can be prior purchased (from Dorian Industries) or hired on the day of the event at \$15 extra cost to be included in the Entry Fee, plus mounting brackets @ \$7.50, if required.

1. **Authority:** This Event is held under the FIA International Sporting Code (ISC), the CAMS National Competition Rules (NCR) and Standing Regulations for Speed Events, these Supplementary Regulations, and any further regulations issued by the organising club. **9. Event Format**

Cars will be divided into five (5) colour groups based on previous lap times recorded at the same circuit in the same vehicle. In the event that an driver has not competed at the track before, he/she will be placed in the "First Timers" group to determine their appropriate colour group, or if times are available from another circuit on the table below, then they may be placed in a group relative to those lap times.

The following colour groups will be used (refer table below for splits) and groups sent out in the order below: **Note: Time splits below are approximate, and actual Groupings may vary based on the Entry list and nominated/estimated previous best times.**

a) Red – Open Wheelers and Lotus Clubman-style cars (lightweight with little protection)

Cars will be started in pairs, the number of pairs **as per the track capacity** shown for the circuit in the Supersprint Guidelines. Please specify number of pairs: **7 Pairs**

Each run will comprise **a minimum of 3 flying timed laps**, with the time for the fastest single lap being used for results. Please specify number of proposed laps **3 laps per run**

Proposed **minimum number of runs on the day** (please specify): **4**

(Note: The Event will not be concluded when this minimum is achieved. Event will only be concluded early for safety reasons or if no competitors available)

**Note: Grouping of pairs of cars to form a 'mini-race' anywhere on the circuit is NOT permitted, and action will be taken by the Clerk of the Course if such an incident takes place.**

**10. Familiarisation Session.**

**Two** familiarisation laps behind a pace car will be given to drivers that have not previously competed at the track and **Nominated for Familiarisation on their Entry Form**. They may be accompanied by a L2S Licence holder or higher with a minimum of 3 years experience as a passenger to assist in pointing out flag points, braking markers, racing lines etc. **Such passenger advice will be encouraged, as its benefits are obvious. This will not be at race speed and overtaking will not be permitted. Both occupants must wear appropriate attire as per Section 13 (Driver Safety), below. Familiarisation start time is at 9:20 am and finishes at 9:30 am**

**11. Entries.**

a) Maximum number of Driver entries for the Event: **110**; Reserves: **10**

b) Maximum number of Drivers per competitor **2**. Dual entry of drivers in the red group (refer clause 9: **Open wheelers and Lotus clubman style cars**) will be at the discretion of the organising club.

f) Closing Date: **Wednesday 14th April 2010**

- g) A pit usage fee of **\$0** per garage will be levied by the circuit owners.
- h) Entries will be accepted in order of receipt and must be sent to the Event Secretary on a **properly completed** Entry Form, accompanied by the appropriate entry fee. Cheques or money orders are to be made payable to the organising Club, "**MG Car Club Ltd**".
- i) Entries from Drivers between 16 and 18 years of age must be counter-signed/consented by a parent or legal guardian on the official entry form.
- j) The Organisers reserve the right to refuse any entry without giving a reason.
- k) Number of venue admission tickets included in entry fee: **tickets not required**
- l) An email confirming acceptance of entries *will be sent to each competitor* (only for entries received more than 5 days before the event). **Note: Email is the preferred method of communication.**
- m) If a competitor advises the event secretary that he/she is unable to attend the event, the following procedure regarding a refund applies:  
  
**Refunds will be given to competitors who notify the Event Secretary of their withdrawal not less than 5 working days before the date of the event**
- n) Any vehicle presented for scrutineering will for the purpose of the entry be deemed to have competed.

## 12. Minimum Licences

Current CAMS Level 2S Licence and a current *club membership card* are compulsory and must be produced on the day of the Event or entry will be denied.

## 13. Drivers Safety.

Drivers must wear:

- (a) A helmet that complies with AS1698 or better and carries marking to that effect, or is otherwise approved by CAMS (see Schedule D Section 1 [Headgear] of the General Requirements for Cars and Drivers, in the current CAMS Manual of Motorsport). Helmets must be in good condition and must not have any perforations to the outer surface.
- (b) Non-flammable clothing extending from neck to wrist to ankles, (apparel of nylon or similar material is forbidden). For State Championship Rounds the minimum acceptable is one piece overalls or Driving Suits. The onus will be on the competitor to prove that older overalls/suits still have fire-resistant properties and are not impregnated with oil or fuel.
- (c) Shoes, which completely cover the feet, made entirely of leather or other flame-resistant materials. Shoes that contain any synthetic materials such as nylon are forbidden.
- (d) In open cars goggles or a visor with a lens material other than glass (ie to AS1609- 1981) are mandatory as are leather or Nomex gloves which entirely cover the hands.

## 14. Vehicle Categories & Classes

**As proposed on attachment marked "Vehicle Category and Classes".**

**Note: Rotary and forced induction engines are subject to capacity multipliers as follows:**

**Rotaries – multiply by 1.8**

**Forced Induction – multiply by 1.7**

**Forced Induction Rotaries – multiply by 3.06**

**Note:** *The Organisers may re-classify any vehicle if they believe it is not eligible for the class in which it has been entered.*

## 15. Scrutineering Requirements.

- a) All vehicles are to be presented at scrutineering and must comply with Schedules A & B of the CAMS General Requirements for Automobiles (as specific in the CAMS Manual), including
  - A fire extinguisher to CAMS requirements and fitted within reach of the driver.
  - A blue **equilateral** triangle, 150mm on each side, mounted to indicate the battery location.

- A secondary method of securing the bonnet.
  - All forward facing glass lenses to be completely covered by a protective film.
  - All loose objects are to be removed from the car.
  - The battery is to be firmly clamped.
  - Vehicles that have been issued with a CAMS Log Book must present the Log Book at Registration and Scrutineering.
- b) Competition numbers are to be positioned on both sides of the vehicle, **on the door and of a height no less than 28 centimetres and must be clearly legible to the timekeeper, and be of a contrasting colour to the surrounding bodywork. Numbers must NOT be on glass. Dual entry numbers must also be shown to the scrutineer.**
- c) Drivers and vehicles must be presented in a clean and tidy manner, completely ready for the track including the driver's apparel and helmet. Any tyre or component changes to the vehicle after scrutineering must be approved by the Chief Scrutineer before the vehicle is taken onto the track. **All competing vehicles must have a valid & signed scrutineering sticker affixed, and also printed with the words "Familiarity" if this vehicle is to run in the Familiarity sessions.**
- d) Any vehicle found to be leaking oil or fluids whilst competing will be suspended from the event until the Chief Scrutineer / Clerk of Course is satisfied that action has been taken to rectify the leak. Should there be a re-occurrence of the leak then the vehicle will be excluded from the remainder of the event.
- e) All vehicles must be fitted with towing hooks or a similar device both front & rear to allow for the speedy removal of a vehicle from a "sand trap" or removal from the circuit in the case of a mechanical failure.

**f) Fuel must be in accordance with Schedule G of the current CAMS Manual.**

A sticker will be issued confirming that the vehicle has passed scrutineering prior to it being able to compete.

**16. Noise.**

Maximum Noise Limit: 95 dba at 30 metres.

Any car found to exceed the maximum noise emission limit will be suspended from the event until the Chief Scrutineer / Clerk of Course is satisfied that action has been taken to bring it within the limit. Any vehicle that exceeds the limit on two runs will be excluded from the remainder of the event. If a vehicle exceeds the noise limit on any lap or laps within a run then only those laps in which the vehicle conformed to the requirements will be allowed for the purpose of the results.

**17. Pre-Event Scrutineering at Circuit**

Start time **7:00 am** Finish time **8:55 am**

*Note: The Event will not be delayed due to late arrivals. It is the Drivers' responsibility to ensure their vehicles are scrutineered before the scheduled starting time of the Event. The driver must attend scrutineering personally so that their driving apparel can be checked.*

**18. Drivers' Briefing** It is compulsory for **ALL** Drivers to attend. Scrutineering will cease whilst the Drivers' Briefing is in progress.

Time **9:00 am** Venue **Control Tower (or as announced)**

**Note: A Driver sign-on sheet must be completed by all Drivers to prove Briefing attendance, failure to sign on may result in penalties being applied by the Stewards of the Meeting. The Organising Club must retain these sheets for any incident or accident reporting.**

**19. Event Schedule.**

**20. Replacement Vehicles.**

At the sole discretion of the Clerk of the Course, a Driver whose vehicle has broken down may use a replacement vehicle. The replacement vehicle must have been scrutineered, and preferably be in the same class and type as the original vehicle. Where the original vehicle has recorded a time and the scrutineered replacement is not in the same class and type as the original vehicle, the replacement vehicle will not be eligible for prizes and/or trophies.

**21. Timing Equipment and Accuracy**

Timing will be **Dorian timing** to an accuracy of .01 seconds.

Those Competitors who don't have a Dorian Timing unit can purchase a unit PRIOR TO THE SUPERSPRINT, or hire a unit on the day from the organisers for \$15 per day.

**Each Competitor MUST have a Dorian unit, and they must be installed as per manufacturer's recommendations.**

Brackets for affixing to the vehicle are \$7.50 each, and are HIGHLY recommended.

**22. Results**

A set of results will be available to all competitors within 5 days of the event. Results will be available on the website [www.natsoft.com.au](http://www.natsoft.com.au). Competitors requiring a hard copy of the results will need to request them at the time of entry.

**23. Prizes / Awards.** (Please Circle)

**Trophies will be awarded as per CSCA guide lines.**

**24 Authority of Officials.** Any Driver not following a reasonable instruction by an official during the Event may be excluded at the discretion of the Stewards of the Meeting. **CAMS Stewards are Judges of Fact.**

**27 Insurance.** Public risk insurance has been effected by the Organisers.

**28 Personal Accident Contribution** is affected by the purchase of a CAMS Level 2S Licence (or higher).

**29 Protests.** Any protests must be made in accordance with the NCR's.

**30 Postponement/Abandonment/Cancellation.** The organisers reserve the right to postpone, abandon or cancel the Event in accordance with the NCRs.

**31 Anti doping policy - Use of prohibited Substances**

During any event, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A of the Current CAMS Manual. In addition, the persons concerned will be subject to the Articles of the Standard Operating Procedure for Alcohol Testing and CAMS Anti-Doping Policy. Competitors, crews or officials may be randomly tested for alcohol by a CAMS Accredited Testing Official (CATO) or other drugs at any time during the event(s).

***Other Prohibited Substances***

The CAMS Anti Doping Policy, as appears in the CAMS Manual of Motor Sport and as amended from time to time, is recognised as an integral component of the National Competition Rules and is duly authorised as such.

In any areas where the National Competition Rules and the CAMS Anti Doping Policy conflict, the CAMS Anti Doping Policy will take precedence.

**32 Refreshment Facilities available. Existing Track catering facilities**

**33. Additions and/or Alterations.**

Any additions and/or alterations to these Supplementary Regulations will be notified to all Drivers in the Final Regulations or during the Drivers' Briefing.
