9. **Event Format:**

i) Cars will be divided into five (5) colour groups based on previous lap times recorded at the same circuit in the same vehicle. In the event that an driver has not competed at the track before, he/she will be placed in the "First Timers" group to determine their appropriate colour group, or if times are available from another circuit on the table below, then they may be placed in a group relative to those lap times. Sorted fastest to Slowest

a) Orange – Open Wheelers and Lotus Clubman-style cars (lightweight with little protection)

b) Green - Under 69 seconds

c) Yellow - 69 to 72 seconds

d) Blue - 72 to 76 seconds

e) White – Over 76 seconds

- ii) Cars will be started in pairs, the number of pairs **as per the track capacity** shown for the circuit in the Supersprint Guidelines. Please specify number of pairs **6**

Each run will comprise **4 flying timed laps**, with the time for the fastest single lap being used for results. This will NOT include the warm up and cool down laps

Proposed **minimum number of runs on the day** (please specify): **4**

(Note: The Event will not be concluded when this minimum is achieved. Event will only be concluded early for safety reasons or if no competitors available)

**Note: Grouping of pairs of cars to form a 'mini-race' anywhere on the circuit is NOT permitted, and action will be taken by the Clerk of the Course if such an incident takes place.**

#### 10. Familiarisation Session.

Three familiarisation laps behind a pace car will be given to drivers that have not previously competed at the track and **Nominated for Familiarisation on their Entry Form**. They may be accompanied by a Clerk of Course approved Licence holder to assist in pointing out flag points, braking markers, racing lines etc.

#### 11. Entries.

- a) Maximum number of Driver entries for the Event: **100** Reserves: **10**
- b) Maximum number of Drivers per competitor **2**. Dual entry of drivers in the Orange group (refer clause 9) will be at the discretion of the organising club.

- d) General Opening Date **1<sup>st</sup> January 2011**

- e) Closing Date **15<sup>th</sup> February 2011**
- f) Carport pit Garages are on a first come basis
- g) Entries will be accepted in order of receipt and must be sent to the Event Secretary on a **properly completed Entry Form**, accompanied by the appropriate entry fee. Cheques /Bank Deposits or money orders are to be made payable to the Organising Club, **Club Lotus Australia Inc.**

- h) Entries from Drivers between 16 and 18 years of age must be counter-signed/consented by a parent or legal guardian on the official entry form.
- i) The Organisers reserve the right to refuse any entry without giving a reason.
- j) **Email confirming acceptance of entries will be sent to each competitor** (only for entries received more than 5 days before the event.
- k) If a competitor advises the event secretary that he/she is unable to attend the event, the following procedure regarding a refund applies:
- Refunds will be given to competitors who notify the Event Secretary of their withdrawal not less than 4 working days before the date of the event**
- l Any vehicle presented for scrutineering will for the purpose of the entry be deemed to have competed.

## 12. Minimum Licences

A.A.S.A. Level 1 or equivalent (eg Level 2S Licence) and club membership card are compulsory and must be produced on the day of the Event.

## 13. Drivers Safety.

Drivers must wear:

- (a) A helmet that complies with AS1698 or better and carries marking to that effect, **Helmets must be in good condition and must not have any perforations to the outer surface.**
- (b) Non-flammable clothing extending from neck to wrist to ankles, (apparel of nylon or similar material is forbidden). Flame retardant overalls or better are highly recommended
- (c) Shoes, which completely cover the feet, made entirely of leather or other flame-resistant materials. Shoes that contain any synthetic materials such as nylon are forbidden.
- (d) In open cars goggles or a visor with a lens material other than glass (ie to AS1609- 1981) are mandatory as are leather or Nomex gloves which entirely cover the hands.

## 14. Vehicle Categories & Classes

**As proposed on attachment marked “Vehicle Category and Classes”.**

**Note: Rotary and forced induction engines are subject to capacity multipliers as follows:**

**Rotaries – multiply by 1.8**

**Forced Induction – multiply by 1.7**

**Forced Induction Rotaries – multiply by 3.06**

**Note:** *The Organisers may re-classify any vehicle if they believe it is not eligible for the class in which it has been entered.*

## 15. Scrutineering Requirements.

- a) All vehicles are to be presented at scrutineering and must comply with Standard Scrutineering Requirements for Supersprints.
  - A fire extinguisher securely attached and within reach of the Driver
  - A blue triangle, 150mm on each side mounted to indicate the battery location.
  - A secondary method of securing forward facing bonnets
  - All forward facing glass lenses to be completely covered by a protective film.
  - All loose objects are to be removed from the car.
  - The battery is to be firmly clamped.
- b) Competition numbers are to be positioned on both sides of the vehicle, **on the door and of a height no less than 28 centimetres and must be clearly legible to the timekeeper, and be of a contrasting colour to the surrounding bodywork. Numbers must NOT be on glass. Dual entry numbers must be shown to the scrutineer. Self Adhesive Numbers will be available on the day @ \$2 each**
- c) **Drivers and vehicles must be presented in a clean and tidy manner, completely ready for the track including the driver's apparel and helmet. Any tyre or component changes to the vehicle after scrutineering must be approved by the Chief Scrutineer before the vehicle is taken onto the track.**
- d) Any vehicle found to be leaking oil or fluids whilst competing will be suspended from the event until the Chief Scrutineer / Clerk of Course is satisfied that action has been taken to rectify the leak. Should there be a re-occurrence of the leak then the vehicle will be excluded from the remainder of the event.
- e) All vehicles must be fitted with towing hooks or a similar device both front & rear to allow for the speedy removal of a vehicle from a “sand trap” or removal from the circuit in the case of a mechanical failure.

- f) **Any vehicle wishing to carry a Recording Camera must apply for approval and have it Scrutineered by the Chief Scrutineer and carry the approval form during Competition**

A sticker will be issued confirming that the vehicle has passed scrutineering prior to it being able to compete.

**16. Noise.**

Maximum Noise Limit: 95 dba at 30 metres.

Any car found to exceed the maximum noise emission limit will be suspended from the event until the Chief Scrutineer / Clerk of Course is satisfied that action has been taken to bring it within the limit. Any vehicle that exceeds the limit on two runs will be excluded from the remainder of the event. If a vehicle exceeds the noise limit on any lap or laps within a run then only those laps in which the vehicle conformed to the requirements will be allowed for the purpose of the results.

**17. Pre-Event Scrutineering at Circuit**

Start time **7:00 am**      Finish time **8:55 am**

*Note: The Event will not be delayed due to late arrivals. It is the Drivers' responsibility to ensure their vehicles are scrutineered before the scheduled starting time of the Event. The driver must attend scrutineering personally so that their driving apparel can be checked.*

- 18. Drivers' Briefing** It is compulsory for **ALL** Drivers to attend. Scrutineering will cease whilst the Drivers' Briefing is in progress.

**Note: A Driver sign-on sheet must be completed by all Drivers to prove Briefing attendance, failure to sign on may result in penalties being applied by the Stewards of the Meeting. The Organising Club must retain these sheets for any incident or accident reporting.**

**19. Event Schedule.**

Start time **9:15m**      Finish time **4:30 pm**

**20. Replacement Vehicles.**

At the sole discretion of the Clerk of the Course, a Driver whose vehicle has broken down may use a replacement vehicle. The replacement vehicle must have been scrutineered, and preferably be in the same class and type as the original vehicle. Where the original vehicle has recorded a time and the scrutineered replacement is not in the same class and type as the original vehicle, the replacement vehicle will not be eligible for prizes and/or trophies.

**21. Timing Equipment and Accuracy**

Timing will be **Dorian Timing Units** and to an accuracy of **0.001 seconds**.

Those Competitors who don't have a Dorian Timing unit can hire a unit from the organisers for \$15/day.

Each Competitor **MUST** have a Dorian unit

Brackets for affixing to the Vehicle are \$7.50 each, and are **HIGHLY** recommended

**22. Results,**

A set of results will be available to all competitors within 5 days of the event by email.

**23. Prizes / Awards.**

**Trophies will be awarded as per CSCA guide lines.**

- 24 Authority of Officials.** Any Driver not following a reasonable instruction by an official during the Event may be excluded at the discretion of the Stewards of the Meeting.

- 30 Postponement/Abandonment/Cancellation.** The organisers reserve the right to postpone, abandon or cancel the Event in accordance with the NCRs.
- 31 Illegal Drugs ("prohibited drugs") and Alcohol.** During any event, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate
